- Also adds: "Indirect supervision" means the same as that term is defined by the division by rule made in accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act

H.B. 86 Adult Autism Treatment Program

Sponsor(s): Craig Hall

Summary

- Creates and describes the operation of this treatment program.
- "Qualified individual" means an individual who is at least 22 years of age, is a resident of the state, has been diagnosed by a qualified professional as having an autism spectrum disorder or another neurodevelopmental disorder requiring significant supports through treatment using applied behavior analysis and needs significant supports for a condition described in Subsection 6c as demonstrated by formal assessments of the individual's cognitive ability, adaptive ability, behavior, and communication ability.
- "Qualified provider" means a provider that is qualified under Section 26-67-202 to provide services for the program... 1) an individual who has a doctorate degree in psychology, is a licensed behavior analyst practicing in the state, and has treated adults with an autism spectrum disorder for at least three years 2) an individual who is employed by the department and has professional experience with the treatment of ASD, 3) three individuals who have firsthand experience with autism spectrum disorders and the effects, diagnosis, treatment, and rehabilitation of autism spectrum disorders, including family members, association representatives, and specialists or professions who work with adults with an autism spectrum disorder
- UOTA Position: Preliminary support, determining if language regarding "qualified provider" is appropriate

H.B. 87 Health Care Workforce Financial Assistance Program

- List of "Geriatric professionals" includes occupational therapist
- "Underserved area" means an area designated by the department as underserved by health care professionals, based on the results of a needs assessment developed by the department in consultation with the Utah Health Care Workforce Financial Assistance Program Advisory Committee created under Section 26-46-103.
- The department may provide education loan repayment assistance to an eligible professional if the eligible professional:
 - agrees to practice in an underserved area for the duration of the eligible professional's participation in the program, and
 - submits a written commitment from the health care facility employing the eligible professional that the health care facility will provide education loan repayment

assistance to the eligible professional in an amount equal to 20% of the total award amount provided to the eligible professional

H.B. 106 Rare Disease Advisory Council

- Creates Rare Disease Advisory Council within the Department of Health
